The Above Nameless Policemen were not wearing their Police Star and Name Tags, and refused to Show me their appointment Cards or give me their names.

I now make the following Affidavit under oath and in English

1.

On the 23rd October 2012, at 12h22 12 Heavily armed "Policemen" led by a white Rambo Cop **Accused No 1** pointing their firearm demanded entry into our home at 6 Cheetah Springs, Cheetah Crescent Rivonia. They all had their firearms out and were pointing them at me at my front door.

2.

They had 5 Police cars and had also blocked the entrance to the Complex. There were more Police with R 5 Automatic weapons

3.

They accused me of murder, attempted Murder, firing a firearm in Public and Pointing a firearm and intimidation.

4.

I asked them for their ID's as none of them were wearing Name tags and they refused to show me their ID's or give me their names.

5.

They stated that they were not obliged to prove their ID's or give me their names." Who the Fuck was I to ask them for ID" From the SAPS **(It is a legal requirement to have your name displayed and produce your appointment Certificate.(Annex B)**

6.

They told me that they would break down the door to the house.

7.

The white nameless Rambo cop **Nameless Accused No 1** said that he would teach me a lesson for trying to Fuck with Mercedes Benz and he was going to "fuck me up"

8.

I have taken Mercedes Benz to the NCC NCE and NPA for **Contravention of Section 68 of the National Credit Act 34 of 2005 and Criminal Prosecution the Consumer Protection Bill 68 of 2008** and in direct violation of the **Constitution of the Republic of South Africa Act 108 Of 1996 and its various amendments**. Copies of all Documents have been sent to the NCR, NPA, NCC, IPID and have been Publically Published.

They are also in contravention of the FICA rules, and a separate Case has been opened, demanding a full FICA Audit. (Annex C and D)

9.

They entered the house and the nameless Policeman (**Nameless Accused No 2** was instructed by nameless Rambo Cop **Nameless Accused No 1** to beat me up and teach me a lesson not to" fuck with Dr Zimmermann and Mercedes Benz"

10.

The nameless Policeman (**Nameless Accused No 2** persistently hit me with his flat hand on the Right side of my head behind my ear.

11.

The nameless Policeman (**Nameless Accused No 2**) Frog Marched me around the House holding me by the back of my collar and the seat of pants and hit me about 30 times. He kept throwing me against the door frames in the house, much to the amusement of all the other "Policemen".

12.

I warned him a number of times that I had a hip replacement and that I complications with the wound and my leg.(I have had 6 operations)

13.

He then in full view of the white Rambo cop, Dead Legged (**Annex E-J**) me about 10 times on the Wound of my hip replacement. (**Annex E J**)

14.

I Told him that I could feel Blood running down my leg and he Continued with the Dead Leg torture.(**Annex K**)

15.

When I complained, the white Rambo Cop said" he is a cheeky Bastard fuck him up and put Hand cuffs on him".

16.

To the great amusement of them all the "Policemen " he started rubbing his groin on the side of my leg simulating a sexual act.

17

I shouted at him to stop acting like pervert and the Rambo cop said “fuck him up and we are going to teach him a lesson for trying to fuck with Mercedes Benz.”

18.

They at Gun Point demanded that we open our two safes as Rambo Cop **Nameless Accused no 1** had a Print out of the Firearms that I owned. As per picture our Safes were raided and the Contents ring by ring were examined and my various wallets were raided. My collection of Silver coins and Kruger Rands were removed from the safe, and I was held back by the seat of my pants while they raided the safe. and Loaded up the contents see annex Annex N) value Missing and stolen between R 487,750-00 and R 570,750-00 by the Rambo Cops.

They refused to list the items or give me a receipt for anything taken.

19.

A number of Cases have been lodged with the Independent Police Investigative Directorate (IPID) covering Theft Assault, Fraud



20.

I was frog Marched down the Driveway by Nameless Cop 2 and they refused to allow me to take my walking aid (walking Stick) Rambo Cop **Nameless Accused no 1** informing everybody that I Was a criminal and that I was being charged with Murder, Attempted Murder and Pointing Fire arm and Firing a firearm. This Included business visitors of

mine and everybody in the complex, such as directors of Anglo American etc.

21

They had blocking the Entrance Gate to the Complex, and there were "Policemen " in uniform and plain cloths with R 5 Automatic Firearms

22

Outside the Complex was a Chev registration no TTW 166 GP which belongs to Mr Rickie Mannie. who laid the Charge against me.

23.

Rambo Cop **Accused no 1** walked over to his car and said " we fucked him up for you. He won't give Mercedes Benz any more trouble".

24.

We want Nameless Policemen arrested and their firearms Confiscated and Charged with the six counts as shown above..

25

We will be bringing a Civil Claim against all the Nameless Policeman

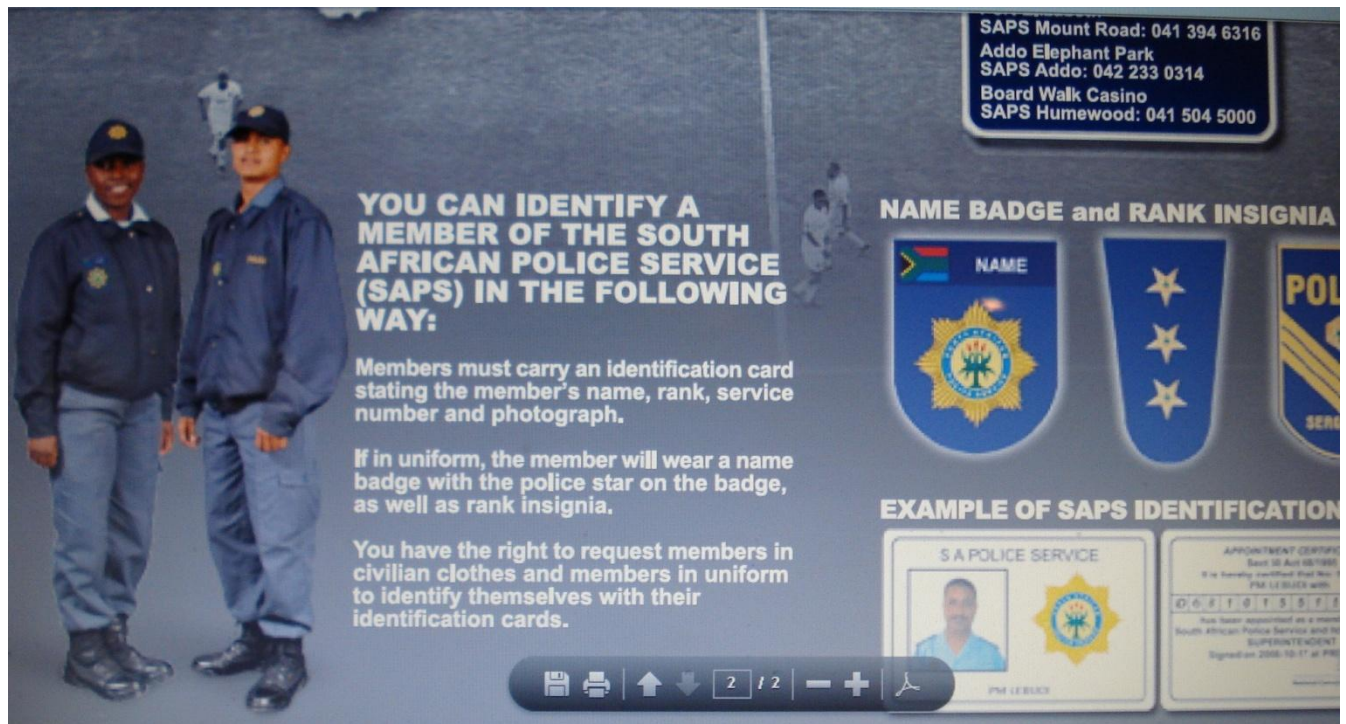

Breach of Purchase Contract : Refusal to Service the Car and Refusal to Carry out the 3 year 75,000KM service all of which is Documented / Complaint againstdr Martin Zimmermann CEO Mercedes Benz South Africa

They refused to carry out the 3 year 75,000km service in terms of the Contract and the Service contract. This is in contravention of various sections of the National Credit Act 34 of 2005 **and various sections of the** Consumer Protection Bill 68 of 2008 **and in direct violation of the** Constitution of the Republic of South Africa Act 108 of 1996 and its various amendments.

The Previous Commissioner Adv Mohlala was aware of the Complaint.

We have made repeated requests to Mercedes Benz to sort out various problems and to date no reaction.

We have also forwarded a Letter of Demand to their CEO Dr Martin Zimmermann a German National, and there has been no response to our Complaint.

It is clear that he has a no care attitude to the Problem and a total disregard to the Laws of South Africa or any of the Acts in place to protect the South African Consumer.

We are there demanding from them you the sum of R 250,000-00 (Two Hundred and Fifty Thousand Rands) damages and a public apology.

Additionally :

We think it is time that the NCC made an example of Mercedes Benz and levelled the Maximum Fine of 10% of their turnover plus a fine of R 5,000,000-00 on Dr Zimmermann.

They are also in **Contravention of Section 68 of the National Credit Act 34 of 2005 plus a Armed Attack with Firearms on my home and placing the safety of my family at risk.**

Because of the Serious nature of their actions we have forwarded the case to the NPA, for Criminal Prosecution.

They are also in contravention of the FICA rules, and a separate Case has been opened, demanding a full FICA Audit.

They have has not responded to any of our emails, or requests for a meeting. We have been unable to get Dr Martin Zimmermann to answer any of our emails (see PDF File attached) and visit <http://www.nameandshame.biz/mercedes.htm> He hides behind a lady called Karola Block who blocks his calls and emails.

Symptoms of a Dead Leg

It hurts because you have been whacked in the leg. You might get swelling or bruising. Restricted movement is not uncommon.

After two to three days check:

- If the swelling has not gone then you probably have an intramuscular injury.
- If the bleeding has spread and caused bruising away from the site of the injury then you probably have an intermuscular injury.
- If you are more able to contract the muscle you probably have an intermuscular injury.
- Can you feel a deformation in the muscle or a gap ?

It is important the correct diagnosis is made because if you try to exercise on a complete rupture, or a bad intramuscular injury you can inhibit healing, make things worse or cause permanent disability. If you apply heat and massage in the early stages then you could get [Myositis Ossificans](#) (or bone forming within the muscle), and then you are in trouble.

Annex I

What is a Thigh Contusion (Dead Leg)?

This type of injury is very common in contact sports. An impact to the muscles can cause more damage than you might expect and should be treated with respect. The muscle is crushed against the bone. If not treated correctly or if treated too aggressively then Myositis Ossificans may occur.

There are two types of contusion:

Intramuscular which is a tearing of the muscle within the sheath that surrounds it. This means that the initial bleeding may stop early (within hours) because of increased pressure within the muscle however the fluid is unable to escape as the muscle sheath prevents it. The result is considerable loss of function and pain which can take days or weeks to recover. You are not likely to see any bruising come out with this type - especially in the early stages.

Intermuscular which is a tearing of the muscle and part of the sheath surrounding it. This means that the initial bleeding will take longer to stop especially if you do not ice it. However recovery is often faster than intramuscular as the blood and fluids can flow away from the site of injury. You are more likely to see bruising come out with this one.

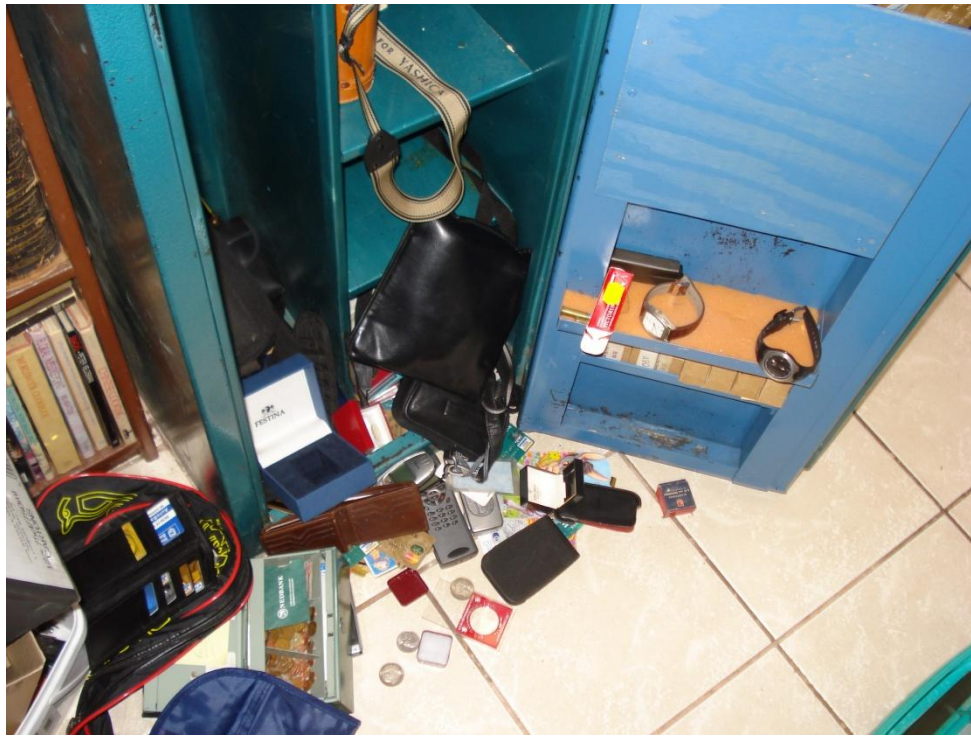
